The person selling the registrations shall hereafter be known as the Donor.

2. Upon completion of the transfer, the agreed payments shall be made to the Donor by Speedy Registrations Co Ltd. Completion is indicated by notification to Speedy Registrations Co Ltd. Completion is indicated by notification to Speedy Registrations Co Ltd of the replacement mark.
3. Speedy Registrations Co Ltd will not accept liability for any losses incurred by the Donor arising from the delays caused by the slow arrival of documents from the buyer or for the failure of the buyer to conclude the transaction.
4. The Donor vehicle must both be taxed and MOT'ed (where of an appropriate age) to qualify for cherished transfer (with the exception of those which qualify under Section 8 of the Department of Transport Rules\*).
5. The Donor undertakes to furnish Speedy Registrations Co Ltd with the necessary vehicle documents when requested. Documents should be supplied immediately to facilitate a speedy transfer but in any event no later than **ONE WEEK** from the date they were first requested.
6. The Donor undertakes to deliver his/her vehicle for inspection by the local vehicle licensing office at the specified time if and when requested.
